## Recipes of the Month - Sausage and Tortellini Soup, and Banana Bread

## Sausage and Tortellini Soup

Servings: 4 Source Credit: Claudia Powell



## Ingredients

- 1 lb Italian Sausage
- 2 quarts chicken broth
- 6 oz baby spinach
- 8 oz tortellini

#### Instructions

Remove casings from sausage and brown in a large soup pot. Add chicken broth and bring to a boil. Add tortellini and cook per package instructions. Stir in baby spinach and cook until wilted. Serve & enjoy.

#### **Banana Bread**

#### Ingredients

• 2 large eggs

#### Instructions

Preheat the oven to 350°F.

In a medium-sized bowl, beat together the eggs, sugar, and oil.

- 1 cup (7oz) sugar
- 1/3 cup (2&3/8oz) vegetable oil
- 1 cup mashed banana (2 to 3 very ripe, large bananas)
- 2 teaspoons vanilla extract
- 1 teaspoon baking soda
- 1 teaspoon baking powder
- 1 teaspoon salt
- 1 teaspoon cinnamon
- 1/2 teaspoon nutmeg
- 2&2/3 cups (11&3/8oz) unbleached allpurpose flour
- 1 cup (8oz) yogurt (or buttermilk, or sour cream)
- 1 cup (4oz) chopped walnuts (optional)

Blend in the mashed banana and vanilla.

Whisk together and then sift (it's important that these be thoroughly combined) the baking soda, baking powder, salt, cinnamon, nutmeg, and flour.

Add all at once to the banana mixture.

Mix quickly but thoroughly, then stir in the yogurt, mixing until just combined.

Pour the batter into a greased and floured 9  $\times$  5-inch loaf pan.

Bake bread for about 1 hour, until a cake tester inserted in the center comes out clean.

If the bread begins to brown too quickly, tent it with aluminum foil after 40 minutes in the oven.

# **Rimfire Members Shoot Competition**

On Saturday, March 19th, we will conduct a member's .22 rimfire shoot competition. There will be four classes; 25 yard open sighted handguns, 50 yard scoped handguns, 50 yard open sighted rifles, and 100 yard scoped rifles. Ammunition will be limited to .22 caliber rimfire; short long, or long rifle, sub sonic or high velocity. Each distance and firearm combination will cost \$5. David Perdue will have sign up sheets and will be taking entry fees at the February dinner meeting. You may also sign up at the March dinner meeting or on the day of the event. Early sign up will help us gauge the number of competitors.

# Message from Torin Miller, Director of Policy, The National Deer Association (NDA)

"The National Deer Association (NDA) has been advocating for the Recovering America's Wildlife Act (RAWA) since its introduction in the 116th Congress. Passage of this bill would be a historic and much-needed conservation victory. Versions of the bill have been introduced in both the House and Senate by Reps. Debbie Dingell (D-MI) and Jeff Fortenberry (R-NE) and Sens. Martin Heinrich (D-NM) and Roy Blunt (R-MO). RAWA provides significant investments in proactive, on-the-ground conservation work led by states, territories, and Tribal nations to support the long-term health of fish and wildlife habitat across America. The bill is scheduled for markup and potential vote in the House Committee on Natural Resources on January 19.

Please consider joining the NDA in supporting this important bipartisan legislation. To ask the Committee Members to vote in favor of the Recovering America's Wildlife Act and send it to the House floor for a full vote, see the congress.gov website page <a href="https://www.congress.gov/bill/117th-congress/senate-bill/2372">https://www.congress.gov/bill/117th-congress/senate-bill/2372</a> where you can click on *Contact Your Membe*r under *Give Feedback*.

RAWA provides \$1.3 billion annually for state fish and wildlife agencies to implement congressionally mandated State Wildlife Action Plans, which outline specific, science-based conservation actions necessary to recover and sustain healthy fish and wildlife populations. These plans include strategies to collectively conserve close to 12,000 fish, wildlife, and plant species identified as "at-risk." RAWA also provides nearly \$100 million to Tribal fish and wildlife managers to carry out similar management and conservation projects on Tribal lands. This dedicated funding will not only boost conservation objectives but will provide increased economic benefits and create new outdoor opportunities for people from all walks of life. The NDA is dedicated to ensuring the future of wild deer, wildlife habitat and hunting. The continuance of the resource, the quality of our hunting experiences and the perpetuity of places to hunt, recreate and relax all rely on intact, healthy habitats and ecosystems. RAWA investments in on-the-ground conservation work will ensure sufficient, sustainable funding for the continued management of our much-loved wildlife resources and their habitats, including the accelerated recovery of 1,600 U.S. species already listed as threatened or endangered under the Endangered Species Act."

## Virginia Department of Forestry Burn Ban

The 4 Pm Burning Law is in effect February 15 to April 30, restricting open air burning until after 4:00 p.m. See <a href="https://dof.virginia.gov/wildland-prescribed-fire/wildfire-prevention/before-you-burn/">https://dof.virginia.gov/wildland-prescribed-fire/wildfire-prevention/before-you-burn/</a> for more information.

The 4 PM Burning Law applies to open-air burning, which means any outdoor fire that is not covered and/or contained within non-flammable barriers. For example, a typical campfire is considered an open-air fire. However, an open-air fire MAY be acceptable if it meets the following criteria: it is completely contained within a ring of rocks, cinderblocks, metal ring, or a similar device and is covered by a ¼ inch or smaller metal screen.
