Recipe of the Month - Buffalo Chicken Chili Slow Cooker

Chapter Ike Cheryl Pisani cooked this chili for the recent chapter chili cookoff. Thanks for sharing the recipe, Cheryl! Serves 6

Ingredients

- 1&1/2 pounds boneless chicken breasts.
- 14.5 ounce can Great Northern beans, drained.
 14.5 ounce can fire roasted diced tomatoes, drained (can substitute regular diced tomatoes).
 14.5 ounce can chicken broth (read label to make sure it's gluten free).
- 1/4-1/2 cup buffalo wing sauce (e.g. Frank's Red Hot).
- 1 package ranch dressing mix envelope (Hidden Valley brand is gluten free).
- 14.5 ounce can sweet corn kernels drained.
- 1/2 teaspoon onion powder.
- 1/2 teaspoon celery salt.
- 1/2 teaspoon garlic powder.
- 1/2 teaspoon dried cilantro. (continued...)

Ingredients (...continued from previous column.)

- 1/4 teaspoon salt.
- 8 ounce cream cheese softened.
- Optional toppings: tortilla chips, fresh cilantro, blue cheese crumbles, additional hot sauce.

Instructions

In a 5 quart slow cooker combine all the ingredients except the cream cheese and toppings.

Cook on high for 4 hours or low for 8 hours. Shred the chicken in the slow cooker using two forks. (You can also use a slotted spoon to remove the chicken to a cutting board, shred it, and then return to the pot.) Add the cream cheese and stir until it is incorporated. Serve with desired toppings.



Izaak Walton Rochester Minnesota

While visiting Rochester Minnesota Alan and Carol Ferguson visited the local chapter of the Izaak Walton League. Their cabin and meeting house is on Silver Lake in Rochester.







The land was purchased in 1936 for \$237 and the cabin was finished in 1938 with a fireplace containing stones from all 48 states, Alaska, Mexico and Canada. Why only 48 states? Because Hawaii and Alaska did not become states until 1959. In 1956 Charles Mayo donated 27 acres of wetlands to the chapter in support of the public use of the 1.8 miles of trails on the property. Many of the species of trees were labeled and it was a great place for a walk in the woods to see wildlife. We saw mallards and a pheasant while walking the trails.

Environmental/Conservation News: Should Menhaden Fishing Be Banned in the Bay?

"In recent years, menhaden have become a major symbol of the bay. The little forage fish is a crucial part of the local ecosystem, a nutrient-dense food source for species from ospreys and eagles to the striped bass and red drum that support the local recreational fishing industry. The fish are also valuable to a commercial fishery dating back more than a century, which harvests hundreds of millions each year to produce fishmeal and fish oil for products like pet food and omega-3 supplements.

Virginia is the last East Coast state that allows menhaden reduction fishing in state waters. Now, environmentalists and sportfishing groups throughout the Chesapeake Bay watershed want the state to ban the fishery in the bay completely. They worry overfishing is threatening the local menhaden population. Omega Protein, the last company harvesting menhaden in the Chesapeake, says there's no evidence backing up the concerns, pointing to recent federal surveys finding the overall East Coast menhaden population appears healthy. Critics argue that data doesn't address what's specifically happening in the bay. The company says banning its operations in the bay would put it out of business, threatening more than 200 local jobs.

Researchers say more data is needed to fully understand what's happening in the bay. But in January, Virginia lawmakers passed on a chance to fund a major study on the status of menhaden. The proposal has been delayed for at least a year. It's the latest chapter in a fight that stretches back decades."
